### Part II: Green Energy Security

Student Project "Measurement of Hazardous Air Pollutants and Policy Analysis with Regard to Environmental Justice in the Atlanta Metropolitan Region"

#### **Project Summary:**

In the 21<sup>st</sup> century technology brings with it many externalities that are harmful to the public; some more so than others. Unfortunately, the State of Georgia is currently one of only five states that have not implemented state-level initiatives to address the issue of environmental justice (disparate exposure of communities to pollution based on race, national origin, or income level). In order to build an evidence base for such legislative action in the state, measurements of pollutant exposures must be conducted with high spatial resolution. This study thus partners GGC faculty and students with an external advisor, Greenlaw — an environmental justice law firm in Atlanta, to collect data to build support for a policy initiative to increase environmental justice in Georgia.

### **Bios**



**Dovilė Budrytė** is a Professor of Political Science and Assistant Dean at Georgia Gwinnett College. She teaches American government, International Relations, International Development and other political science classes here. Her publications include articles and four books, Taming Nationalism? Political Community Building in the Post—Soviet Baltic States (2005), Feminist Conversations: Women, Trauma and Empowerment in Post—Transitional Societies (co-edited with Lisa M.

Vaughn and Natalya T. Riegg, 2009), Memory and Trauma in International Relations: Theories,

Cases and Debates (co-editor with Erica Resende, 2013), and Engaging Difference: Teaching Humanities and Social Sciences in Multicultural Environments (co-editor with Scott A. Boykin). In 2014/15, she was the recipient of the University System of Georgia Excellence in Teaching Award.



Giedrius Česnakas is a lecturer at the Department of Political Science and Diplomacy at Vytautas Magnus University (Kaunas, Lithuania). His doctoral dissertation, "Energy Resources in Russia's Foreign Policy towards Belarus and Ukraine (2000–2012)," won the award from the Lithuanian Academy of Sciences for the best research conducted by junior researchers in the areas of the humanities and social sciences in 2014. He served as a Vice-Dean at the Department of Political Science

and Diplomacy at Vytautas Magnus University (2014-2016) and worked as a researcher at the Energy Security Research Centre at Vytautas Magnus University where he coordinated and coauthored the annual research publication "Lithuanian Energy Security: Annual Review" (2011-2015).



**Dainius Genys** is a researcher at the Energy Security Research Centre at Vytautas Magnus University. Having earned a doctorate in Sociology, he recently completed a post-doctoral project "The Impact of Energy Threats to Lithuanian Social Cohesion." He was a visiting fellow at The Harriman Institute of Russian, Eurasian and East European Studies (Columbia University, New York, USA), at NATO Energy Security Center of Excellence (Vilnius, Lithuania), at the

Maxwell School for Citizenship and Public Affairs (Syracuse University, Syracuse, USA), and Eco Energy Ltd and the Harry S. Truman Research Institute for the Advancement of Peace (Hebrew University, Israel). Dr. Genys has participated in many projects financed by the Research Council of Lithuania and the European Commission.



**Paul Grant** is an Assistant Professor of Political Science at Georgia Gwinnett College. He teaches American Government, State and Local Government, Introduction to Political Science and other political science classes at GGC. He earned his PhD in Political Science at the University of Illinois in Chicago. Dr. Grant is a founder of GGC's Community Garden.



Julius Pranevičius is Consul General of the Republic of Lithuania in New York. He holds BA and MA degrees from the Institute of International Relations and Political Science, Vilnius University. His previous positions include serving as a Director of the European Union Department at the Ministry of Foreign Affairs of the Republic of Lithuania and the Director of the EU Council Presidency Department at the Ministry of Foreign Affairs of the Republic of Lithuania.



Laura D. Young is an Assistant Professor of Political Science at Georgia Gwinnett College. She received her PhD in Political Science from Purdue University with a concentration in International Relations, Comparative Politics, and Political Behavior and Institutions. Her research interests focus on security studies, specifically issues related to environmental crises and resource scarcity and the resulting impact of these events on state development and society.



**Kathryn Zimmermann** is an Assistant Professor of Chemistry at Georgia Gwinnett College. She received her PhD in Environmental Toxicology from the University of California, Riverside. She has extensive research in atmospheric reactions of PAHs and completed a post-doc in Atmospheric Chemistry from the University of California, San Diego.
